INDEPENDENT AUDITOR'S REPORT TO THE MINISTRY OF WATER AND ENERGY SECOND URBAN WATER SUPPLY AND SANITATION PROJECT

We have audited the financial statements of Ministry of Water and Energy, Second Urban Water Supply and Sanitation Project, financed under IDA Credit Nos. 60070- ET and 60080- ET, which comprise the balance sheet as at 7 July 2021, and the statement of sources and uses of funds and a Designated Account statement for the year then ended, and a summary of significant accounting policies and other explanatory information.

1. PROJECT INFORMATION

The Project Development Objective (PDO) is to increase access to enhanced water supply and sanitation services in an operationally efficient manner in Addis Ababa and selected secondary cities. The project comprises three components:

Component 1: Addis Ababa sanitation and water supply services improvements;

Component 2: Sanitation and water supply services improvement in second Cities; and

Component 3: Project management and institutional strengthening (Federal and Regional level).

The Project is financed through IDA Credit Nos. 6007-ET and 6008-ET, Regular Credit and Scale-up Facility Credit respectively, signed between the Government of the Federal Democratic Republic of Ethiopia and the International Development Association (IDA) on 7 April 2017.

The Project became operational on 1 May 2018and would be closed on 7 July 2023.

2. SIGNIFICANT ACCOUNTING POLICIES

a) Basis of preparation

These financial statements have been prepared in accordance with the Ethiopian Government's Manual of the Federal Accounting System which is based on a modified cash basis of accounting.

b) Currency

These financial statements are presented in Birr. Transactions in foreign currencies are translated into Birr at the approximate rates of exchange prevailing at the dates of the transactions. Cash balances denominated in foreign currencies are translated into Birr at the exchange rates ruling at the balance sheet date.
