	In the table of contents of part-2-Works Requirements, several sections are listed to be include this part. However, the topics listed under section VII-Work requirements after are not present serial number 2.25, "standby power generator plant" are not present in the document. Thus, kindly provide the documents, such as technical specification, Mechanical particular specification, raw water and clear water pump stations and treatment plant particular electrical requirements and others.	In the Table of Contents of Part 2-Works Requirements, several sections are listed to be included under this part. However, upon reviewing Section VII-Works Requirements, we have noted that the content following Serial Number 2.25, titled "Standby Power Generator Plant," is missing from the bidding document posted on the ministry website page. This includes the technical specifications, mechanical particular specifications, and the particular and General electrical requirements for the raw water and clear water pump stations, as well as the treatment plant. Therefore, the missed technical specification are attached to the ministry website with the title "missed parts of the technical specification" in considering it as first amendment. However, the word format of the technical specification having the missed page is already uploaded on ministry website page. The missed page is only in the scanned document and for legality and bidding
	We kindly request a word version of the technical documents in MS word format as converting the scanned file to an editable format has proven to be quite challenging.	Please refer to the Master Bid Document (PDF scanned format), starting from page 217, or under Section VII – Works Requirements, page 89, which pertains to the Standby Power Generator Plant. We have noted that the section following Serial Number 2.25 appears to be missing. Accordingly, please find the attached document for your clarification. The technical specification in word format is uploaded in full as requested, but the official one is the one having the seal of the ministry. Therefore you can downloaded from the web page: https://www.mowe.gov.et/en/
	In addition, as this is a quite elaborate and not a small tender, we are concerned about the time in our hands and the closing date. We are writing this letter to confirm a discrepancy between the BOQ, which specifies a maximum pump and motor length for the multi-stage vertical inline shaft pumps should not exceed 2000mm, and the drawing, which shows a pump length of 6000mm.

We kindly request clarification on this matter to ensure alignment and avoid any potential misunderstanding during implementation

After reviewing your bid documents, we kindly request clarification on the following points:

- Can you please send us the technical specifications for the Bridge (traveling) crane and Monorail crane?
 - 2. Can you please send us the detailed technical specifications for the laboratory equipment?
 - Can you please provide the technical specifications and length of cable, as the cable length and diameter are not specified in the BOQ

For the clean water and booster pumping station, as shown in the drawing, the

electric submersible pump is installed vertically within a casing with a total length of 6

meters Casing. Of this, 3 meters are submerged below the Original Ground Level (OGL),

while the remaining length extends above the surface. The above-surface portion must be

equal to or greater than the wet well overflow level. The casing's inlet is located at the

bottom. Accordingly, the drawing includes the following details: the OGL elevation, the

minimum and maximum water levels in the booster reservoir, and the pump's position.
