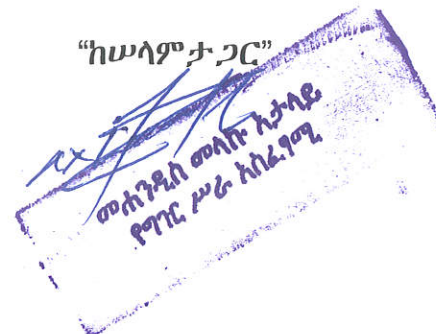

The objective of the assignment is to Selection of Consulting Firm in preparing the National Electrification Project's Capacity Building Roadmap (AF-ELEAP)

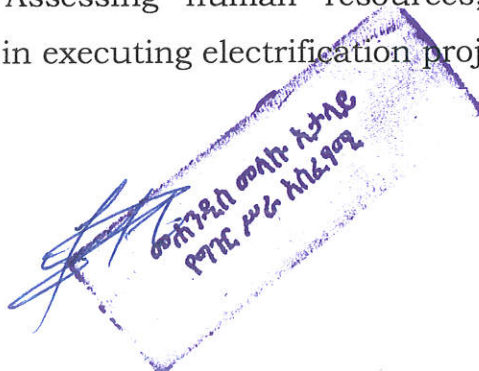
Scope of work

The selected consultancy firm will be responsible for the following key tasks:

3.1 Assessment of EEILEO existing Capacity to Implement the National Electrification Program

The assessment will evaluate the Ministry's existing institutional, technical, financial, and operational capabilities, identifying strengths, gaps, and areas for improvement. Key focus areas include:

- ✦ **Institutional Framework** – Reviewing EEILEO organizational structure, roles, and coordination mechanisms for program implementation.
- ✦ **Technical Capacity** – Assessing human resources, expertise, and technological capabilities in executing electrification projects.



- ✦ **Financial Resources** – Evaluating funding sources, budget allocation, and financial management systems supporting the program.
- ✦ **Operational Efficiency** – Analyzing workflows, processes, and logistical capacity to execute projects effectively.
- ✦ **Stakeholder Engagement** – Examining collaboration with government agencies, private sector partners, and international organizations.

3.2. Facilitating the Roadmap Workshop

- ✦ Organize and facilitate the Roadmap workshop, ensuring active participation from key stakeholders in the electrification sector.
- ✦ Guide the development of a clear and actionable roadmap for the implementation of the National Electrification Program (NEP), including identifying priorities and establishing timelines for key activities.
- ✦ Preparation of a One-Day Workshop for 30 Participants, at Adama city including EEILEO staff and representatives from the World Bank Group. The workshop will be fully facilitated with all necessary logistical arrangements, Venue and Logistics, Refreshments, Daily Subsistence Allowance (DSA) and any others costs.

3.3 Preparation of Capacity Building Road Map Plan

- ✦ Collaborate with EEILEO and the World Bank to review the preliminary capacity-building needs assessment for EEILEO.
- ✦ Develop a comprehensive capacity-building plan for EEILEO, incorporating prioritized actions for institutional strengthening and addressing technical and management gaps.
- ✦ Ensure the capacity-building plan aligns with the objectives of DLI 3, particularly focusing on the effective development of EEILEO's technical, managerial, and institutional capacities.
